Spaces are \$595.00 payable in advance for the State Fair season, or \$35.00 a day or \$195.00 per week. The State Fair season is 30 days: July 8th, through August 7th, 2010. All spaces have full hook ups: water, sewer, and power.

- 1. To apply for a trailer space, please complete this application form and return it with your rental fee to the RV Park Office (make checks payable to: CAL EXPO).**
- Spaces will be allotted on a first-come, first-served basis and full season exhibitors will be accommodated before other applicants. After full season exhibitors have been assigned space, short term exhibitors will be assigned space, and then non exhibitors will be assigned space. Submitting an application does not guarantee space.
- 3. ALL APPLICATIONS AND PAYMENTS MUST BE RECEIVED BY JUNE 25th, 2010.** You may confirm your space allocation by calling the RV Park Office at (916) 263-3187 after June 15th.
- Every effort will be made to accommodate specific site requests. However, sites fill quickly and it is not always possible to accommodate all requests. **No refunds will be made after JULY 1st, 2010.**
- Only one RV, travel trailer, or 5th wheel per site. We do not allow tent camping. Tenant agrees to abide by Park Rules (see attached).
- Shuttle service is available daily during the state fair from the RV Park entrance into the fairgrounds for your convenience.
- ALL VEHICLES must have license plates and current registration during occupancy in the park. A valid driver's license and proof of registration may be required upon check in.

We hope you have a pleasant stay at our facility. In order to make your stay and the stay of other RVers around you a happy experience, we would like to ask you to observe some good RV camping practices. Please advise the park host of any condition that requires attention.

- **Check in time is 1:00 PM. Check out time is 11:00 A.M. Please advise us by 9:00 AM if you are planning to stay another day.**
- Quiet hours are from 10:00 PM to 7:00 AM.
- Speed limit in RV park is 5 MPH.
- Please keep RV space clean. No storage is permitted under or around RVs. ALL VEHICLES MUST FIT INTO YOUR SPACE. Parking in empty hook-up spaces, in fire lanes, or in visitor parking is not permitted. Illegally parked vehicles may be cited and/or towed. All RV's must stay in assigned space. Visitors may park in visitor parking when available, otherwise they may park outside the entrance to the park. All **vehicles must have license plates and current registration during the time of occupancy.** No vehicle repair is allowed in the park. Washing of RV's in the Park is not allowed.
- Children must be supervised by an adult at all times.
- Clothes-lines are not permitted. Wind break with management approval.
- No recreational use of skate boards, bicycles, motor bikes/scooters or roller skates.
- Pets must be on leash at all times. No pets in buildings. No pets on grass please.
- Pets must be kept quiet and under control. No pets may be left unattended.
Thank you for cleaning up after your pet. Dog station is located next to Site 313.
- STATE and COUNTY LAWS REQUIRE:
 - ✍ No open fires. Barbecue grills and camp stoves are O.K.
 - ✍ No draining of sink water onto camping area.
- Restrooms and showers are for RV patrons only. Please help us keep these facilities clean. Deposit is required for a key to the showers. Keys must be turned in prior to departure for return of deposit. Locks are changed often.
- Laundry facilities are for RV patrons only. Please help us keep this area clean.
- Do not attempt to gain entry to events on the Fairgrounds except through regular admission gates or in performance of your duties if participating in the event.
- Please pay only for the days that you are sure you will be here, as the park office does not give refunds.
